CITY OF MT. VERNON, ILLINOIS REGULAR CITY COUNCIL MEETING Tuesday, July 5, 2016 7:00 P.M.

MINUTES

The Mt. Vernon City Council held a Regular City Council Meeting on Tuesday, July 5, 2016 at 7:00 p.m. at the Rolland W. Lewis Community Building, Veterans Park, 800 South 27th Street, Mt. Vernon, IL.

The invocation was given by Rev. Terry Edwards of the Prince of Peace Lutheran Church.

The Pledge of Allegiance was recited.

ROLL CALL

Roll call showed present: Council Members Jeff May, Dennis McEnaney, Donte Moore and Mayor Mary Jane Chesley. Absent: Council Member Todd Piper.

PRESENTATION OF JOURNALS

The Journals for the June 13, 2016 City Council Workshop Meeting, June 20, 2016 Regular City Council Meeting, and the June 22, 2016 Special City Council Meeting were presented to Council for their approval.

Council Member Moore made a motion to approve the Journals as presented. Seconded by Council Member McEnaney. Yeas: May, McEnaney, Moore and Chesley. Absent: Piper.

APPROVAL OF CONSOLIDATED VOUCHERS FOR ACCOUNTS PAYABLE

The Consolidated Vouchers for Accounts Payable were presented to Council for approval. Council Members requested additional information regarding the following items: #16 N Kohl Grocer Company - \$6,596.58 – concession food for resale at the Aquatic Zoo. This represents food to be sold at the Aquatic Zoo. #26 Traffic and Parking Control - \$12,410.27 – flashing signs for 45th and Veterans Memorial Drive. This intersection is also known as the Wells Bypass Road and Veterans Memorial Drive. Additional traffic signs are being installed in anticipation of the increase in traffic due to the opening of the new high school. #1 Alldata - \$2,544.00 – data subscription services for software in Fleet Maintenance Department for tracking vehicle parts. #8 ET Simonds - \$43,510.35 – Ambassador Road Construction. This represents the last payment for that road project. #9 Employers and Operating Engineers Local 520 - \$13,635.85 – benefits compensation owed by Moniger Excavating, Inc. for the Richview Road sidewalk project. Moniger failed to make a payment to Union Local 520 so the City deducted the payment amount from what Moniger was owed by the City. The City made the

payment to Local 520 on Moniger's behalf. #15 Key Benefits Group - \$2,367.00 – printing and mailing fees for 2015 Affordable Care Act 1095 Form reporting. Employers are required to inform employees of the type of coverage they have; their dependents covered; and the period of the coverage. #23 Security Alarm Company - \$1,519.00 – alarm system upgrade and monitoring service for Tourism Department in case of fire. #24 Shores Builders - \$10,000.00 – final payment for work on Aquatic Zoo which was held until satisfactory completion of the project. The project is complete. A special check was written to The SMB Help Desk in the amount of \$8,600.00 for a Microsoft exchange server for City employee email. This is necessary in order to archive all emails. #3 Baldwin Media Development - \$1,800.00 – video shoot for Tourism Department. This promotional video will be used on the City's website and Facebook page as well as in other promotional advertising of the City.

Council Member McEnaney made a motion to approve the Consolidated Vouchers for Accounts Payable in the amount of \$1,247,064.31. Seconded by Council Member Moore. Yeas: May, McEnaney, Moore and Chesley. Absent: Piper.

BIDS & QUOTES

Bechtel presented for Council's consideration the results for the Requests for proposals for City Websites. Tourism Director Angela Schrum appeared and noted that she received five proposals. After extensive research and consideration, Schrum recommended that the City accept the proposal submitted by Louder Designs, of Dallas-Fort Worth, TX. Louder will design a website for the Tourism Department (www.enjoymtvernon.com) at a cost of \$10,000.00 and for the City of Mt. Vernon (www.entvernon.com) for a cost of \$8,000.00.

Council Member Moore made a motion to accept the proposal for City Websites from Louder Designs for a total of \$18,000.00 — \$10,000.00 Tourism; \$8,000.00 City. Seconded by Council Member May. Yeas: May, McEnaney, Moore and Chesley. Absent: Piper.

Bechtel presented for Council's consideration the bid results for the Maintenance Materials Using MFT (Motor Fuel Tax) Funds. Only one bid was received as follows:

Bechtel noted that the bid was \$8,480.55 over the Engineer's estimate. Public Works Director Matt Fauss will adjust the projects to be completed this fiscal year and not exceed the budgeted amount for maintenance materials using MFT funds.

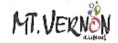

McKenna briefed the Council on the new "Mow to Own" program that kicks off July 18 to will allow residents to acquire vacant properties owned by the city by maintaining the property. Instead of paying a dollar amount, residents work to acquire ownership of neighboring property. At this time, the city owns 88 vacant properties, which have been declared surplus. McKenna said another 10 properties are expected to be added after the current round of demolitions are completed. Under terms of the program, 501(c)(3) non-profits and owner/occupied residents with property adjacent to a vacant lot owned by the city can sign up at city hall to maintain the property for two years to earn a quit-claim deed. Maintenance includes mowing, raking leaves, removing fallen trees and branches, and picking up the trash. After the two-year period, they must not have had any nuisance, zoning or building violations, their utility account must be up to date; and they have to have paid their property taxes on their own property. If they have done that, they will get the deed. McKenna, who has been spearheading the implementation of the program, said the idea for the Mow to Own program was brought to his attention by Councilman Donte Moore who heard of the program from St. Louis. A list of the surplus properties is available by contacting McKenna or in the City Clerk's office. Additional information about signing up for the program is available by contacting McKenna at 242-6805.

Bechtel presented for Council's consideration a Request for Permission to Close North 9th Street from Main Street to Harrison Street for the "Counting Cars and Help for Kids" car show. Bryn Hubbard, co-owner of Tri Moon Vapes, stated the car show features a meet and greet with Ryan Evans and a car show to benefit area kids. "Ryan Evans is my cousin, he's on the TV show 'Counting Cars.' He's from here, our parents are siblings," said Bryn Hubbard. Evans will be at Tri Moon Vapes from 4 p.m. to 8 p.m. on Friday, July 22. The entry fee to see him will be a new toy for a child, an unused school supply or a monetary donation. The toys will be given to the Jefferson County Toys for Kids. The car show will be held in conjunction with the meet and greet. For more information or to register a car, call Tri Moon Vapes at 315-6666. CITY ATTORNEY

City Attorney Bill Howard presented for Council's consideration Second Reading of an Ordinance Regarding Prevailing Wage Rate. This annual Ordinance, pursuant to Illinois Statute 820 ILCS 130/1-12, determines the prevailing wage rates to be paid to laborers, mechanics and other workers engaged in the construction of public works coming under the jurisdiction of the City to be the same rates as determined by the Illinois Department of Labor as of July, 2015. According to the Department of Labor, 2016 rates are not available as this time.

Council Member McEnaney made a motion to Approve Ordinance No. 2016-19 Regarding the Prevailing Wage Rate. Seconded by Council Member May. Yeas: May, McEnaney, Moore and Chesley. Absent: Piper.

Howard presented for Council's consideration First Reading of an Ordinance Dedicating Real Estate for Use as Public Roads at the new Industrial Park. Bechtel advised that a Right of Way Dedication Plat and Permanent Right of Way Dedication Description for the new Industrial Park are necessary in order for a Warranty Deed to be issued to purchasers of land in the Industrial Park. In addition, development and use of the Industrial Park requires the establishment of public roads within the Industrial Park. Three new roads will be created, namely: Phoenix Drive, Vernois Drive and Neon Drive.

Council Member May made a motion to suspend the rules to vote on an Ordinance. Seconded by Council Member Moore. Yeas: May, McEnaney, Moore, and Chesley. Absent: Piper. Council Member May made a motion to adopt <u>Ordinance No. 2016-20</u> Dedicating Real Estate for Use as Public Roads in the new Industrial Park. Seconded by Council Member Moore. Yeas: May, McEnaney, Moore and Chesley. Absent: Piper.

Howard presented for Council's consideration an Ordinance Approving TIF Agreement with J & R Appliance. The restoration project by owner Jim Schomaker will include masonry work and façade improvements including restoring the leaded art glass panels, cornice restoration, decorative lighting and awnings. The TIF grant shall not exceed \$50,950.00 and will be paid in equal installments of \$10,190.00 per year for five years.

Council Member McEnaney made a motion to adopt <u>Ordinance No. 2016-21</u> Approving the TIF Agreement with J & R Appliance. Seconded by Council Member May. Yeas: May, McEnaney, Moore and Chesley. Absent: Piper.
