#### **CITY MANAGER**

City Manager Mary Ellen Bechtel presented information including the proposed design for the Downtown Greenspace. A copy of the design was included in the packet. The Council discussed the design. It will be placed on the City's website for community members to review. Council members were all in agreement that this design is going to be a great addition for the downtown area.

City Manager Mary Ellen Bechtel requested permission to Go Out for Bids for Financing Through the Downtown TIF for the Downtown Greenspace. The City can support \$2 million of the cost of the park from future tax increment in the Downtown TIF. The City would want to bid the financing of \$2 million and the balance would come from other City funds and grants.

Information for license applications from other municipalities was given to Council members. Mayor Lewis shared additional information regarding food trucks and itinerant vendor licenses and tax information. City Manager Mary Ellen Bechtel also spoke about the current application and information required regarding licenses. Deputy City Clerk Becky Barbour discussed some of the problems that have been encountered with licensing within Mt.

Vernon and other communities. City Attorney David Leggans also answered questions on licensing and alternative regulations and requirements.
