# City of Mt. Vernon, Illinois Regular City Council Meeting Monday, August 2, 2021 7:00 p.m.

The Mt. Vernon City Council held a Regular City Council Meeting on Monday, August 2, 2021, at 7:00 p.m. in the City Council Chamber at City Hall, 1100 Main Street, Mt. Vernon, Illinois. Facebook Live: <u>https://www.facebook.com/MtVernonIL</u>.

Due to the absence of Mayor John Lewis, Deputy City Clerk Becky Barbour called the meeting to order. The first order of business was to appoint a Mayor Pro Tem. The City is passing along the reimbursement to the residential accounts covered under this contract. Staff recommendation is to approve the addendum to the contract. City Attorney David Leggans presented a Resolution to Approve Agreement for Professional Services with Round Table Design, Inc., Relating to 2022 IEPA Water Main Replacement. This contract is for \$150,000.00, which includes updating the water modeling and updating all the reports to the State of Illinois and the bidding.
